## **Administration**

The Cavalier King Charles Spaniel Club of Victoria Inc. is affiliated with Dogs Victoria, and these trials are conducted under the Rules and Regulations of Dogs Victoria; an electronic copy of these documents will be held with the Trial Secretary and may be viewed on request.

This is a Restricted to Height trial, and is open to all dogs and bitches on the Main, Limited, and Associate Registers that measure under 500mm at the shoulder as per the current ANKC rulebook requirements.

Handlers are responsible for cleaning up and removing droppings left by his or her dog; there are plenty of bag dispensers on hand around KCC Park.

## **Trial Precincts**

The trial precincts are the entire judging area, plus an exclusion zone of 20 metres around all rings as set up. No off-leash training or exercise is permitted within the precincts of the trial.

Bitches in oestrus shall not be permitted to compete in the trial, nor remain within the precincts of the trial.

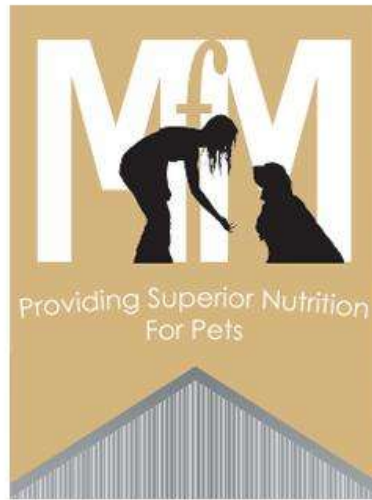
