Conditions of entry: A separate entry is required per dog for each class. Jump height to be stated for each dog entered in Open, Utility, Rally Advanced & Excellent classes. Entries must be from the Group 5 breeds listed on the Main or Limited Register to be accepted as a condition of entry. GSDCV membership to be noted on entry.

The GSDCV reserves the right to add or reduce the judging panel.
