OFFICIATING JUDGES ARE PERMITTED TO ENTER AT THESE TRIALS, IF ELIGIBLE

Entrants in the CCD Class are not eligible for Highest Score in Trial.

Conditions of Entry: One entry per entry form. Open & Utility must state dog's JUMP HEIGHT and all titles. Rally Advance and Excellent Classes must state dog's JUMP HEIGHT and all titles.

Entry Fees: \$15 per class + \$3 for printed catalogue, if required, **must be ordered with entry, none available for sale on the day of the trial.**
