PRECINCTS OF THE TRIAL

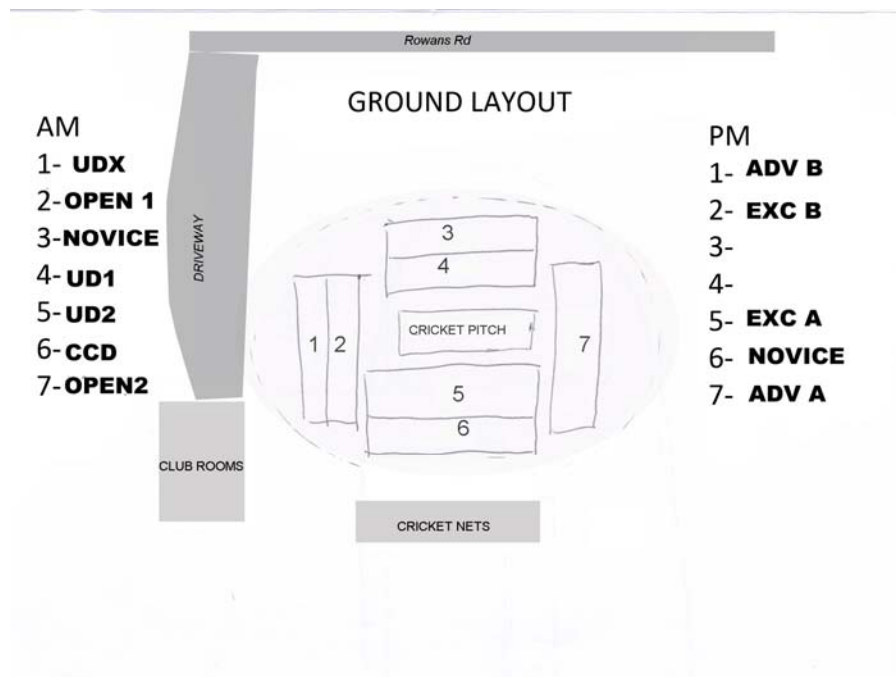
The Precincts of the Trial is the area within the football oval fence line.
