PRECINCTS OF THE TRIAL

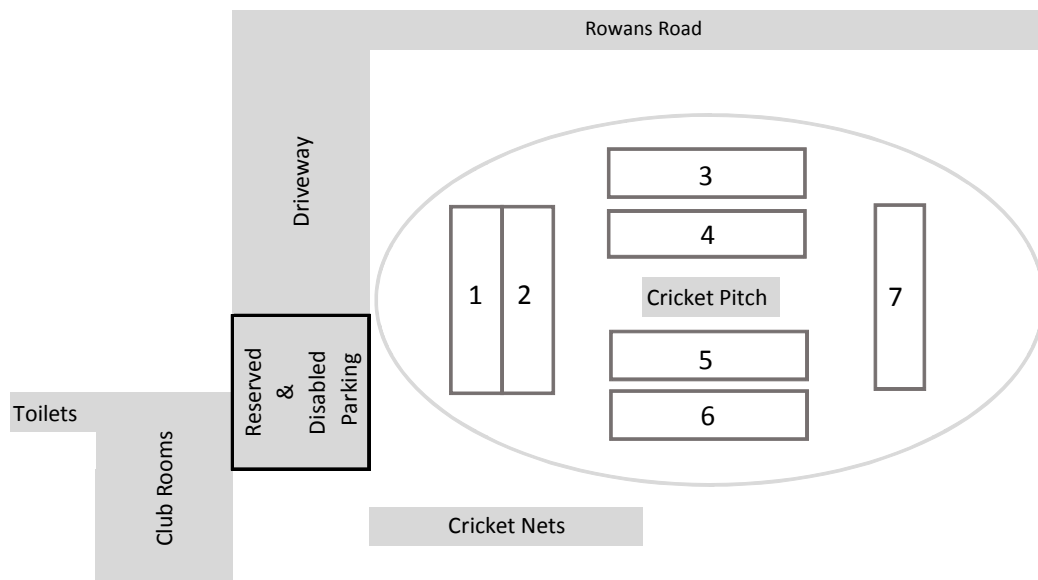
The precincts of the Trial is the area within the football oval fence line.
