Vetting is required for all bitches entered in the trial.

### IMPORTANT NOTE - CATALOGUE NUMBERS

To assist competitors we are trialling one number per dog for the entire day. This means regardless of what classes you have entered you have the same number. It also means that dogs may not run in sequential order. You will need to make sure you are aware of your position in the running order of the ring and be ready (we have added a column in the running order for you). We would appreciate feedback from judges, competitors and stewards.

### COMPETITORS

As we have some large classes, please be prompt to your ring so we have no delays.

Every effort has been made to accommodate handlers who have entered in multiple classes, however clashes may still occur. It is your responsibility to notify the Assembly steward if you are required or likely to be required in another ring.

If any details in the catalogue are incorrect it is your responsibility to advise the Trial Secretary as soon as possible. Pass cards will not be re-printed.

At all times a competitor shall be responsible for cleaning up droppings left by his or her exhibit, including the Athletic oval and ground surrounds areas.

Excessive barking will not be tolerated – please be very mindful of the residents.

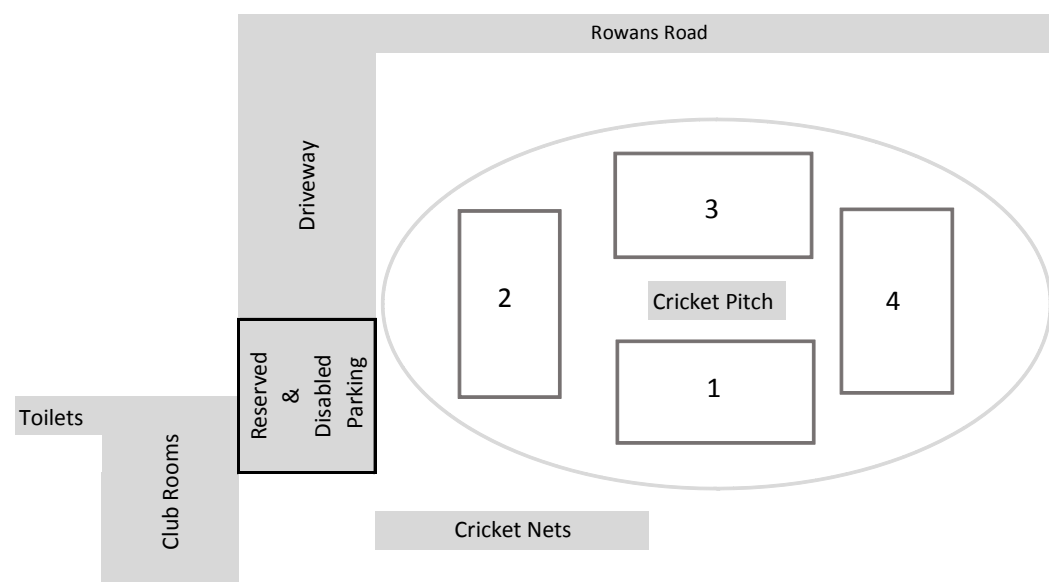
## PRECINCTS OF THE TRIAL
