Please note that the precincts of the trial include the area where tracks are laid. Please adhere to trial officials instructions when in the trial area.

Please be mindful of responsible dog ownership, and keep your dog under control, and on lead over the weekend. We have promised the landowners that dogs will be on lead at all times. When taken to your tracking area, you are reminded that competitors are asked to stay within the vicinity of the parking area until directed by the judge or steward/s.

Working Dog Club of Victoria Medallions will be presented for titles gained.

It would be helpful if attendees wear articles (at least 6); during the trial, in case they are needed to lay tracks. Please be careful to bring warm, waterproof clothing. Although the Mornington Peninsula generally has a mild climate it can still get very windy and cold at times, so bring your winter woolies and waterproof gear.

Hot water, tea, coffee and bread and sausages will be provided and we will bring a BBQ if you wish to cook for yourself or you never know, someone may volunteer. There are no shops close by. The nearest shopping centre is in Balnarring

There may be a **very limited** number of track ons available for those who gain a pass within a title. Eg if you pass Test 1 or 2 you may be offered a Test 2 or 3 if we have tracks available. There will be less track ons than previous years as we have a larger than usual entry.
