Directions

The trial will be conducted on land in Merricks North, **Melways Map 162 C5**. If travelling from Melbourne on the Peninsula Link freeway take the Balnarring exit (C784) and veer left towards Balnarring at Tuerong Junction. After crossing Foxeys Road, turn right onto **Tubbarubba Road** and look for **No. 38 on your right**. The gate is 2065 metres from the start of Tubbarubba Road (as measured by the Dog Tracker app.) There will be some tracking flags to help find the gate. *If you reach the entrance to the Baillieu Vineyard, you have gone too far.*

Once inside the property, follow the formed gravel road uphill and into an area of bush where there is a flat parking area near a large hayshed.

Please note that the precincts of the trial include the area where tracks are laid. Please adhere to trial officials instructions when in the trial area.

Please be mindful of responsible dog ownership, and keep your dog under control, and on lead over the weekend. We have promised the landowners that dogs will be on lead at all times. When taken to your tracking area, you are reminded that competitors are asked to stay within the vicinity of the parking area until directed by the judge or steward/s.

Working Dog Club of Victoria Medallions will be presented for titles gained.

It would be helpful if ALL attendees wear articles (at least 6); during the trial, in case they are needed to lay tracks. Please be careful to bring warm, waterproof clothing. Although the Mornington Peninsula generally has a mild climate it can still get very windy and cold at times, so bring your winter woolies and waterproof gear.

As we will not have access to a kitchen or mains power, communal catering facilities will be limited to a camping gas stove and a "sausage sizzle" at lunchtime. Otherwise, competitors are requested to provide for their own needs for food and other refreshments. There are no shops close to the trial site. The nearest shopping centres are in Balnarring and Bittern.
