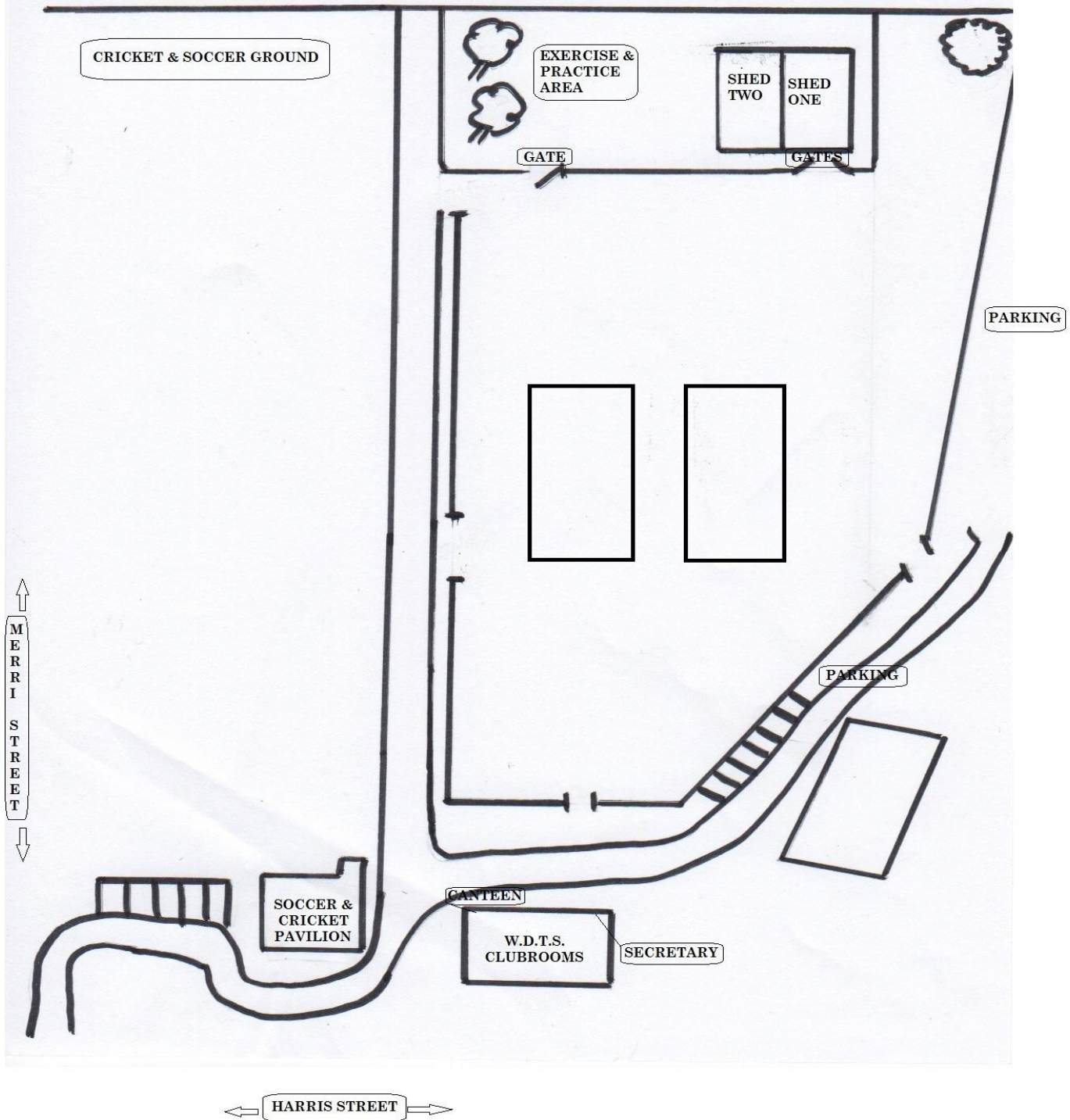
We wish you every success at our trial and we hope you enjoy your stay in Warrnambool and please drive home safely.
