When taken to a tracking area, you are also reminded that competitors are asked to stay within the vicinity of the parking area until directed by the judge or steward/s. Please be mindful of responsible dog ownership, and keep your dog under control, and on lead over the weekend whether at the clubhouse car park or out at paddock tracks. We have promised the farm land owners that dogs will be on lead at all times.
