TRIAL INFORMATION FOR JUDGE, STEWARDS AND COMPETITORS

- Masks are not required to be worn by any official or competitor however if you choose to do so you may. It would be a good idea to carry a mask with you at all times
- There will be no catering available it is recommended that all attendees bring their own food and drinks
- Please remember COVID safety and if you are unwell, go home
- · Gazebos can be set up
- Toilets have been cleaned and there is sanitizer available in the clubrooms

CHECK IN AND VETTING

- Exhibit numbers will be provided at check in
- Competitors must check themselves in (no collecting of other's numbers allowed)
- Please be mindful of social distancing. If there are lots of people around come back in
 5 minutes we will ensure that everyone gets the opportunity to check in
- Competitors will vet their own bitches and your exhibit number will be stamped for you

ASSEMBLY AND RUNNING OF RING

- The Judge will manage their ring in the manner they see fit and we ask you follow their direction. Stewards will have sanitized their hands throughout the day and will provide items to the handlers.
- Competitors will need to keep their own lead in the ring for both obedience and rally
- Competitors should maintain 1.5 meter distancing when lining up to enter the ring
- Spectators are not to congregate at ring entrances or exits

RING TABLE

- There is a table in the ring for you to place your belongings when you enter the ring
- There will be hand sanitiser and wipes for the judge and steward
- Competitors will need to keep their own lead in the ring for both rally and obedience

COURSE WALKING - RALLY

- Competitors should try to maintain as much distance as possible and not congregate in areas
- Competitors should move away from the signs when discussing handling options to avoid congregating in large groups
- · Competitors will need to keep their own lead in the ring for both obedience and rally
- Rally score sheets will be handed to the competitor after their run. Please take these with you.

PACK UP

 Competitors are encouraged to help with pack up. Please ensure hand sanitizer is used after touching equipment

PRESENTATIONS

- Presentation of trophies will take place at the conclusion of judging both the Obedience and Rally trial
- Masks may be worn during presentations held indoors
- Physical distancing is to be maintained
