
# Victorian Herding Association Inc. Herding Trial

#### **Vetting/Check In & Judging times:**

- Competitors MUST check in during these times to compete in the trial, the exception being stock suppliers who are also trailing.
- The run order of the trial shall be advised on the day by the Trial Secretary and will be planned to maintain the comfort of the stock in accordance with the prevailing weather conditions.

#### **Precincts of Trial**

- An exclusion zone of 5 metres around the perimeter of all judging courses will apply for all spectators and 10 metres for dogs, excepting stock handlers and dogs used for stock setting.
- No bitch in season or showing a discharge will be permitted within this zone without prior permission
  of the Trial Secretary. Any bitch in season will compete at the end of the day.

#### During active judging:

- It is entirely decision of the judge to select their preferred site from which to judge
- Aspiring judges may shadow judge as long as they maintain a 10m exclusion zone from the judge, until the end of each run
- Spectators should maintain a 15m exclusion zone from the judge

#### Risk

Under ANKC Rules & Regulations for Herding, Ch 1, Sec 7, owners or handlers of dogs in herding tests and trials shall agree to assume responsibility for any damage or injury to stock.
