

NB: Competitors MUST check in during these times to compete in tests and trials

EXTREME HEAT:

If the forecast temperature for either trial day is to exceed 30 deg Celcius (as per the Bureau of Meteorology website – District Forecasts/Central District/Wonthaggi) the trial will BEGIN at 7am and suspend trialling once the temperature reaches 30 deg C and recommence when the temperature drops below that point. If extreme heat action is taken, check in will be at 6.45 for cattle and duck exhibitors and 7.30am for sheep exhibitors.
