## **Dogs Victoria Top Obedience Dog/s of the Year**

The competition in its three forms has been running continuously since 1992. Originally the pedigree and non-pedigree, (associate dogs) were separated into separate rings. The first event was won by Shenfield Kennels with a Shetland Sheepdog and the non-pedigreed section was won by Kim Hone with her Kelpie. Since 1993 all breeds including non-pedigree compete together. That was a battle well fought.

This award is highly prized among the obedience fraternity and the competition has always been watched with great interest.

Sadly, over recent years, obedience has been challenged by other disciplines. Not necessarily easier, but more dog friendly, in some cases. After declining entries, the OTEC have come up with another idea, borrowed from NSW.

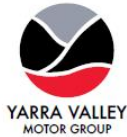
