IMPORTANT INFORMATION

Our venue is at the Wodonga Racecourse on Wilson Street at Wodonga.

If you're coming up on the Hume Hwy, take the second off ramp – at the set of lights turn Right on to High Street.

Drive straight through the main street – to the big roundabout at the Water Tower. Go straight through this roundabout (Beechworth Rd), and continue on till Wilson St on your left (another roundabout!)

Turn left onto Wilson Street and go straight through till the left turn corner at the end. The main gate of the Wodonga Racecourse is on your right before that corner – it's an automatic gate so approach it slowly.

The caravan sites are on the right as you go through the gate.

We have all of the 8 sites for our Trial.

There are hot showers and toilets available.

Cost per night is \$20.00 - payable to the Wodonga Kennel Club.
