Directions

The trial will be based at No 6834 Maroondah Highway, Yarck. If you are travelling from Melbourne, the entrance to the property is on your *right*, 2.3 km past the Yarck Hotel. The entrance will be marked with tracking flags on the 3 days of the trial.

Note that some GPS units will attempt to take drivers to a more distant property – **look for the flags!**

Thank you to all the helpers who have worked so hard to make this trial possible, especially the judges and stewards who will work all weekend, plus the additional helpers who have volunteered to set out and lay tracks or to help in other ways.

Facilities Please be aware that Yarck is a small town where fuel is **not** available. There is a hotel and a bakery but no supermarket. The nearest service station and supermarket are in Alexandra.

Catering Limited catering will be available at the trial site. The Club will provide tea, coffee and hot water, a gas barbeque, bread and sausages.

Tracking on may be possible for those who gain a pass within a title. E.g. if you pass Test 1 or 2 you may be offered a Test 2 or 3 if tracks are available. If you wish to track on, please ensure that you bring your cheque book (if you still have one!) or \$35 cash for the additional entry fee – no EFT facilities! Unfortunately, we cannot guarantee that everyone who may be eligible to track on will be able to do so.

Please note that passes towards any tracking title must be gained under **at least two judges**, so if any passes towards your dog's current title have been awarded by **either of the judges** who are officiating at this trial, please inform the Trial Secretary.
