TRIAL PRECINCTS: Mown grass areas bounded by paths (2 sides) and fences (2 sides)

NUMBERS AVAILABLE: AM: 7:30 – 8:00am. And through the morning as required. Exhibitors must collect numbers prior to competing. No check-in. No vetting.

CLASHES: As a competitor it is your responsibility to inform the stewards if you are competing in the other ring and it is especially important to keep the stewards informed if a clash is likely to occur.

JUDGING TIMES: Both rings start at 8.00am. 2nd event follows but not before 9.00am.

PRESENTATION: Pass cards will be presented at ringside 10 -15 minutes after the last run while the next class is walking or while the equipment is being packed away.

PLEASE CHECK: Spelling and titles in the catalogue as pass cards will be printed according to the catalogue unless you tell us otherwise (Any word cut-offs in catalogue due to lack of space will not be repeated on pass cards. Pass cards will have full titles, etc.)

CATERING: Not Available.

AWARDS: No awards, prizes or sashes. Pass cards only

PLEASE NOTE RE PARKING: – No parking available on grounds. Note also that Council has installed a fence between the car park and the grounds prohibiting direct access except near the clubhouse. Apparently access gates will be installed later.

RUNNING ORDER & JUDGES

Ring 1: Novice Agility, Master Agility: **Adrian Tilley**

Ring 2: Open Agility, Excellent Agility: **Clive Makepeace**

Note: 200 and 300 dogs will be given 10% extra SCT in Excellent, Open and Master, not Novice. Placings will be decided on raw times.

From the Trial Secretary:

Welcome to our trial. In order to avoid clashes between Open and Masters, there will be 2 walk throughs for Masters. The first will be for 500s only and the second for all the other heights.

The 500s will be first in Open and should all be finished by the time the masters is walking.

The other heights walk-thru will be after the 500 dogs have run by which time they will have finished open. Please stick to the walk-thru you are allocated as there are 19x500 dogs but only 11 dogs of other heights. Thank you to everyone at the club and their partners who have given so much time and effort to contribute to the smooth running of this trial.
