Thank you to all the helpers who have worked so hard to make this trial possible, especially the judges and stewards who will work all weekend, plus the additional helpers who have volunteered to set out and lay tracks or to help in other ways.

Catering Limited catering will be available at the trial site \$5 payable on the day. i.e. the Club will provide tea, coffee, milk, hot water.

Tracking on may be possible for those who gain a pass within a title. e.g. if you pass Test 1 or 2 you may be offered a Test 2 or 3 if tracks are available. If you wish to track on, please ensure that you bring your cheque book (if you still have one!) or \$40 cash for the additional entry fee – no EFT facilities! Unfortunately, we cannot guarantee that everyone who may be eligible to track on will be able to do so.

Please note that passes towards any tracking title must be gained under **at least two judges**, so if any passes towards your dog's current title have been awarded by **either of the judges** who are officiating at this trial, please inform the Trial Secretary before you arrive.

Be prepared to travel to your track when requested. This will require you to have your own transport.

COVID Safe Plan

Advice for attendees at the Tracking Trial on the 28 – 30th May 2021.

The trials will be conducted in accordance with Victorian Government requirements current at the time. This document provides details for the conduct of the tracking trials in a COVID safe manner.

General information:

Attendees must maintain social distancing and must use a mask if social distance cannot be maintained.

Carrying a mask with you, at all times, remains a Victorian Government requirement. Judges, stewards, and exhibitors do not generally need to wear masks whilst tracking. Of course if you wish to track wearing a mask please do so it is your preference.

Attendees will be asked to abide by social distancing when setting up their chairs and their equipment. This may mean that chairs should be at least 2m apart on all sides to allow handlers and dogs to move through....etc.

1. Advice to handlers

- Handlers must inform the trial secretary of any extra attendees registered on Easy Dogs; that are not trialling. Additional visitors on the day must register via the sign in sheet provided.

- Handlers will need to be aware that judges and stewards will be using hand sanitiser etc.

- **People must not attend if they have any of the following symptoms – fever, sore throat, dry cough, runny nose or shortness of breath. This applies to those with even the mildest of symptoms.**

- **Any person who, in the last 14 days, has returned from overseas, been unwell, or had close contact with a known or suspected case of COVID-19 will be asked to leave the site.**

2. Check In

- A record will be kept of the name, mobile phone number and arrival time of every person in attendance for contact tracing purposes. These records will be based on a list of attendees generated by the online entry system. Any additional attendees are to check-in with the Trial Secretary to sign in.

- Handlers must use hand sanitiser at check-in.

- All bitches will be vetted by their owners under supervision.

3. Exhibitors' Catering

- **Limited catering will be provided. These will be available as single serve items.**

6. Etiquette

- Handlers cannot borrow a pen from the steward or judge.

- Only the judge should touch their judge's folders.

- Handlers cannot touch the steward's folders.

7. Toilets

- **When entering the toilet block please wear your mask. No loitering in the toilets at all. Toilets will be cleaned by the organisers.**

8. Parking

- All attendees are reminded that social distancing should still be maintained in the parking area.

9. COVID Officer

- A suitably trained official will be designated to oversee to ensure compliance and ensure the safety of all attendees. Please obey any directives they may give.

EXHIBITORS PLEASE NOTE

1. PLEASE NOTE AFTER TRACKING, IF YOU ARE SUCCESSFUL THE JUDGE WILL ADVISE THE TRIAL SECRETARY OF THE RESULTS AND YOUR QUALIFYING CARD WILL BE READY FOR YOU BACK AT BASE CAMP.

2. AFTER RECEIVING YOUR CARD AND SASH YOU WILL BE ABLE TO LEAVE THE TRIAL AND WILL BE LOGGED OUT AS PER THE COVID PLAN.

3. ANY PERSONS NOT SUCCESSFUL MUST ALSO COME BACK TO BASE TO ADVISE THEY ARE LEAVING TO BE LOGGED OUT AS PER THE COVID PLAN.
