## Gippsland Obedience Dog Club Inc – Open Tracking Trial COVID Safe Plans

### **Advice for attendees at the Gippsland Obedience Open Tracking Trial on 17<sup>th</sup>, 18<sup>th</sup> and 19<sup>th</sup> July 2021.**

The trials will be conducted in accordance with Victorian Government requirements current at the time. This document provides details for the conduct of the tracking trials in a COVID safe manner.

#### **General information:**

Attendees must maintain social distancing and must use a mask if social distance cannot be maintained.

Carrying a mask with you, at all times, remains a Victorian Government requirement. Judges, stewards, and exhibitors do not generally need to wear masks whilst tracking. Of course, if you wish to track wearing a mask please do so it is your preference.

Handlers are to provide their own equipment, food & water for their dogs.

#### **1. Advice to handlers**

- Handlers must inform the trial secretary of any extra attendees registered on Show Manager; that are not attending. Additional visitors on the day must register via the sign in sheet provided.
- Handlers will need to be aware that judges and stewards will be using hand sanitiser etc.

- **People must not attend if they have any of the following symptoms – fever, sore throat, dry cough, runny nose or shortness of breath. This applies to those with even the mildest of symptoms.**
- **Any person who, in the last 14 days, has returned from overseas, been unwell, or had close contact with a known or suspected case of COVID-19 will be asked to leave the site.**

## 2. **Check In**

- A record will be kept of the name, mobile phone number and arrival time of every person in attendance for contact tracing purposes using the club QR code or sign in sheet. These records will be based on a list of attendees generated by the online entry system. Any additional attendees are to check-in with the Trial Secretary to sign in.
- Handlers must use hand sanitiser at check-in.
- All bitches will be vetted by their owners under supervision.
- Volunteers must use their own pens or clean pens before and after use.

## 3. **Etiquette**

- Handlers cannot borrow a pen from the steward or judge.
- Only the judge should touch their judge's folders.
- Handlers cannot touch the steward's folders.

## 4. **Toilets**

- **When entering the toilet block please wear your mask. No loitering in the toilets at all. Toilets will be cleaned by the organisers.**

## 5. **Parking**

- All attendees are reminded that social distancing should still be maintained in the parking area.

## 6. **COVID Officer**

- A suitably trained official will be designated to oversee to ensure compliance and ensure the safety of all attendees. Please obey any directives they may give.
