**TRIAL INFORMATION FOR JUDGES, STEWARDS, COMPETITORS**

Welcome everyone to our trial. It has been a long-awaited day and we have been busy preparing through COVID requirements. Please see below an outline of what is required for a smooth (hopefully) day. We are hoping that these measures will also allow everyone to leave as soon as they have finished for the day. By all means please feel free to stay longer however we know many have a distance to drive. With a large entry the day is going to be long, we ask for patience with our Judges and stewards and request everyone is at their ring on time to prevent unnecessary delays with Judging.

As per directions everyone attending needs to be double vaccinated in order to enter the grounds. When you arrive at the club we will need to see evidence. As per Dogs Victoria the only acceptable forms of proof are as follows:

- An online or saved copy of the Australian government certificate of COVID vaccination
- The certificate of vaccination uploaded to the Services Victoria app
- A printed copy of your vaccination certificate for COVID
- A copy of your medical exemption

**OUR CLUB MEMBERS ARE VOLUNTEERS, PLEASE TREAT THEM WITH RESPECT**

QR code check-in will be completed as cars enter the property. We ask that you use the QR to begin your check-in procedures before you reach the front of the queue. As you reach the front of the queue you will need to show that check-in has been completed. This will allow the process to be faster. This process is all new to us too and we are hoping to make it as smooth and effortless as possible. Make sure you have your phone with you to complete this process. We are here to help if there are issues so please do not stress.

Our normal dog check-in and vetting procedures are the same where you collect your entry number. Catalogues are not being printed and provided.

**Everyone:**

- Masks are required to be worn as per the CHO direction at the time
- Please remember COVID safety and if you are unwell, go home
- Gazebos can be set up providing there is at least 1.5m from other set-ups
- Catering will be available throughout the day. Please social distance near this area.
- Depending on final entries the lunch break will be from approximately 12:00-12:45 with the afternoon session starting around 1:00pm.

### **Judges/Stewards:**

- Those who need judging before the start time please arrange with the respective judge
- There is a tub for each ring with all required sashes, ribbons, first place money, sanitiser, wipes etc.
- Judges will complete presentations ringside **as soon as the class has finished**. Pass cards will be available to collect from inside the clubrooms from the table with the class name displayed.
- The procedure for RALLY judging will be as follows:
  - Judges will work through their first class and complete presentations ring side
  - Whilst walk through for the second class is happening, pass cards will be signed and available for collection inside the clubroom.
  - After the second class has finished presentations will be made ring side again
- Rally score sheets will be handed to the competitor after their run. Please take these with you.
- The procedure for OBEDIENCE judging will be as follows:
  - At the conclusion of stays, presentation will be made. Please stay to support others.
  - Pass cards will be available inside once they have been signed
- Ring boards will be available for viewing. Please speak with the steward before touching.

### **Competitors:**

- Exhibit numbers will be provided at check in at the end of the clubrooms as per pre-COVID times
- Competitors will vet their own bitches and these cards will be stamped for you
- The club has **no** requirement for additional tubs/boxes/bags etc to be provided at the ring to separate items. Judges will manage their ring in the manner they see fit and we ask you follow their direction. Competitors need to be on time and not place their equipment on the table until it is their turn to enter the ring. It is expected the handlers will not be returning to the table during judging to collect items as this will slow the ring procedure. Stewards will have sanitised their hands throughout the day and will provide items to the handlers.
- Pass cards can be collected from inside the clubrooms during the day. Ribbons are available as well.
- Due to large classes we ask handlers to consider withdrawing if their dog is not performing and non-qualifying. This will help those judges who have a large workload on the day.
