TRIAL INFORMATION FOR JUDGES, STEWARDS, COMPETITORS

Welcome everyone to our trial. It has been a long-awaited day after rescheduling our fixture from October to November with everything crossed and hoping nothing goes wrong. Like everyone, we are looking forward to moving back to a bit of trial normality. Please see below for what we are hoping will be an issue free day and fingers crossed not too much rain. We ask for patience with our Judges, stewards, club workers and fellow competitors on the day.

As per the CHO directions everyone attending the fixture is required to be double vaccinated. When you arrive at the club, we will need to see evidence of your double jab. As per the CHO the only acceptable forms of proof are as follows:

- An online or saved copy of the Australian government certificate of COVID vaccination
- The certificate of vaccination uploaded to the Services Victoria app
- A printed copy of your vaccination certificate for COVID
- A copy of your medical exemption

OUR CLUB MEMBERS ARE VOLUNTEERS, PLEASE TREAT THEM WITH RESPECT DURING THIS PROCESS

QR code check-in will be completed as cars enter the property. We ask that you use the QR below to begin your check-in procedures before you reach the front of the queue. As you reach the front of the queue you will need to show that check-in has been completed. This will allow the process to be faster.

This process is all new to us and hoping it will be a seamless process on the day. Make sure you have your phone with you to complete this process. We will have the QR code available when you arrive if you forget to print out this page. If you do not have a phone capable, we will have an iPad for you to sign in, however you will be required to have a copy with you of your double vaccination certificate to show. We are here to help if there are any issues, so please do not stress.

Judges/Stewards:

- Those who need judging before the start time please arrange with the respective judge
- Ring boards will be available for viewing. Please speak with the steward before touching.

Competitors:

- Exhibit numbers will be provided at check in at the end of the clubrooms as per pre-COVID times
- Competitors will vet their own bitches and exhibit numbers will be stamped for you
- The club has no requirement for additional tubs/boxes/bags etc to be provided at the ring to separate items.
- Judges will manage their ring in the manner they see fit and we ask you follow their direction.
- Competitors need to be on time and not place their equipment on the table until the competitor currently in the ring has collected theirs on leaving the ring.
- It is expected the handlers will not be returning to the table during judging to collect items as this will slow the ring procedure.

- Masks are not required to be worn when outside but must be worn if entering the clubrooms or toilets on the day
- Masks are to be always carried as per the CHO direction at the time
- Please remember COVID safety and if you are unwell, please go home
- Gazebos can be set up providing there is at least 1.5m from other set-ups

- Please maintain social distance throughout the day.
- Depending on final entries the lunch break will be from approximately 11:30-12:15 with the afternoon session starting around 12:30pm.
