COVID INFORMATION

As per Dogs Victoria policy everyone attending needs to be double vaccinated in order to enter the grounds. When you arrive at the club, we will need to see evidence.

The only acceptable forms of proof are as follows:

- An online or saved copy of the Australian government certificate of COVID vaccination
- The certificate of vaccination uploaded to the Services Victoria app
- A printed copy of your vaccination certificate for COVID
- A copy of your medical exemption

Upon check in, you will be issued with a red wrist band. This will confirm you have shown your double vaccination status and are good to enter the grounds.

Don't forget to collect your entry numbers and vet your dogs, if required.

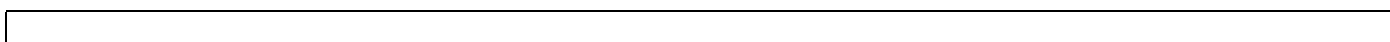

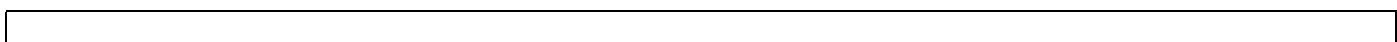

Please note the following:

There are some handlers with multiple dogs and/or entries in more than one class. It is your responsibility to notify the relevant stewards if you are competing in other rings, especially if there is the possibility of clashes. Notwithstanding the above, competitors should make every effort to be at ringside when their name is called to facilitate smooth operation of the ring in Catalogue order.

Walk through of the Novice & Advanced rings will be at 9:50am for 10 minutes.
