Advice for attendees at the Tracking Trial on the 20 to 23 May 2022.

The trials will be conducted in accordance with Victorian Government requirements current at the time. At this time QR checking in is no longer required and masks are no longer need to be worn.

General information:

Attendees must maintain social distancing when possible.

Common Sense:- Please think about social distancing when setting up your chairs and their equipment. This may mean that chairs should be a distance apart on all sides to allow handlers and dogs to move through....etc.

1. Advice to handlers

- **People must not attend if they have any of the following symptoms – fever, sore throat, dry cough, runny nose or shortness of breath. This applies to those with even the mildest of symptoms.**
- **Any person who, in the last 14 days, has returned from overseas, been unwell, or had close contact with a known or suspected case of COVID-19 will be asked to leave the site.**

2. Check In

- All bitches will be vetted by their owners under supervision.
- Check in will be at the front of the kitchen area, the smallest of the buildings at Victoria Park.

3. Exhibitors' Catering

- **No catering will be provided. Exhibitors should bring their own food and drinks if required.**

7. Toilets

- We ask that you do not loiter in the toilets at all. Toilets will be cleaned by the organisers.

8. Parking

- Please do not park on the grassed area of the main area.

Statement of Risk

Safety Procedures for Tracking Trials

- 1) Trials are held over undulating and hazardous terrain, it is suggested that sturdy footwear and clothing to be worn to reduce the possibility of scratches or injury. As with all outdoor activities it is suggested competitors and spectators have appropriate clothing for the weather and take due care when moving around the trial site and training area.
- 2) The environment, animals and wildlife can be inhospitable. Be alert and avoid any inhospitable animals and wildlife where possible.
- 3) Trials take place near water. If you cannot swim take care around the water. If you have children in your custody it is your responsibility to ensure the safety and welfare of the children at all times.
- 4) We are privileged to be allowed onto this land by the farmers, remember it is their home and well as their business so please be respectful at all times to staff and to the paddocks we are using..

You must therefore:

- a) remove all rubbish from the property.
 - b) do not enter any dwelling on a property without permission.
 - c) do not touch any farm equipment on the property.
 - d) **ensure dogs to be kept on lead at all times, whilst at this trial.**
That means whilst tracks and other times and around livestock..
 - e) all gates must be left as they are found when entering a paddock.
- 5) The first aid box will be back at the base, of any trial. If emergency first aid is required contact base, and the appropriate steps will be taken.
