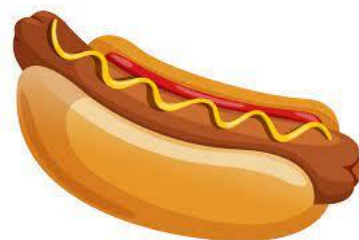
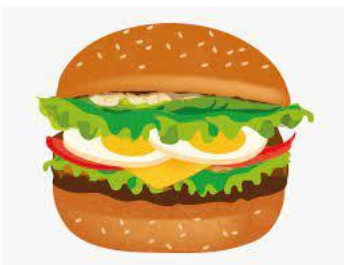

## TRIAL INFORMATION FOR JUDGES, STEWARDS, COMPETITORS

### **Judges/Stewards:**

- Masks are not required of any official
- There is a tub for each ring with all required sanitizer, wipes etc. These will be used as needed by all. The 1st Place prizes and ribbons will be delivered to the rings as the Pass Cards are ready
- Trial 1 Presentations will be on the Verandah once all Pass Cards are completed and Signed. Trial 2 Judges will complete presentations at the ring at the completion of all their Judging. Qualifying ribbons and title sashes will also be available for those who would like them from the Office.
- Rally score sheets will be handed to the competitor after their run. Please take these with you.
- Each ring will have a table for you to place your belongings as you enter the ring
- Ring boards will be available for viewing. Please speak with the steward before touching.

### **Competitors:**

- Exhibit numbers will be provided at check in on the verandah. Please only take your own numbers and be mindful of social distancing on the verandah. If there are lots of people around come back in 5 minutes we will ensure that everyone gets the opportunity to check in
- Competitors will vet their own bitches and these cards will be stamped for you
- The club has **no** requirement for additional tubs/boxes/bags etc to be provided at the ring to separate items. Judges will manage their ring in the manner they see fit and we ask you follow their direction. Stewards will have sanitized their hands throughout the day and will provide items to the handlers.
- Competitors will need to keep their own lead in the ring for both rally and obedience
- Rally walk through requirements are as per the rule book. Judges will ensure everyone has their walk through opportunity.
- Ring boards will be available for viewing. Please speak with the steward before touching.

- Please remember COVID safety and if you are unwell, go home
- Carry a mask with you at all times
- Gazebos can be set up
- Masks are not required to be worn however if you choose to do so you may
