Competitors must not bring any odours (birch, anise, clove, cypress) to the venue and must not undertake any scent training on the property.

CAR PARK: Car Park behind Club rooms . Enter from Heaths Road.

CHECK IN: 5.15-5.40pm. Late check in available if pre-arranged.

BRIEFING: 5.45pm

JUDGING: 6pm

AWARDS: Sash and Eukanuba for first, second and third place.

Qualifying ribbons and cards, and Title sashes will be awarded.

PRESENTATIONS: Conducted at the end of judging.

CATALOGUE: Please check that all dogs' names and titles, as well as handler details, are correct, and notify check-in attendants of any errors. Details must be accurate to ensure that pass cards are valid.

NO CATERING AVAILABLE: Please bring your own snacks and drinks, place rubbish in bins.

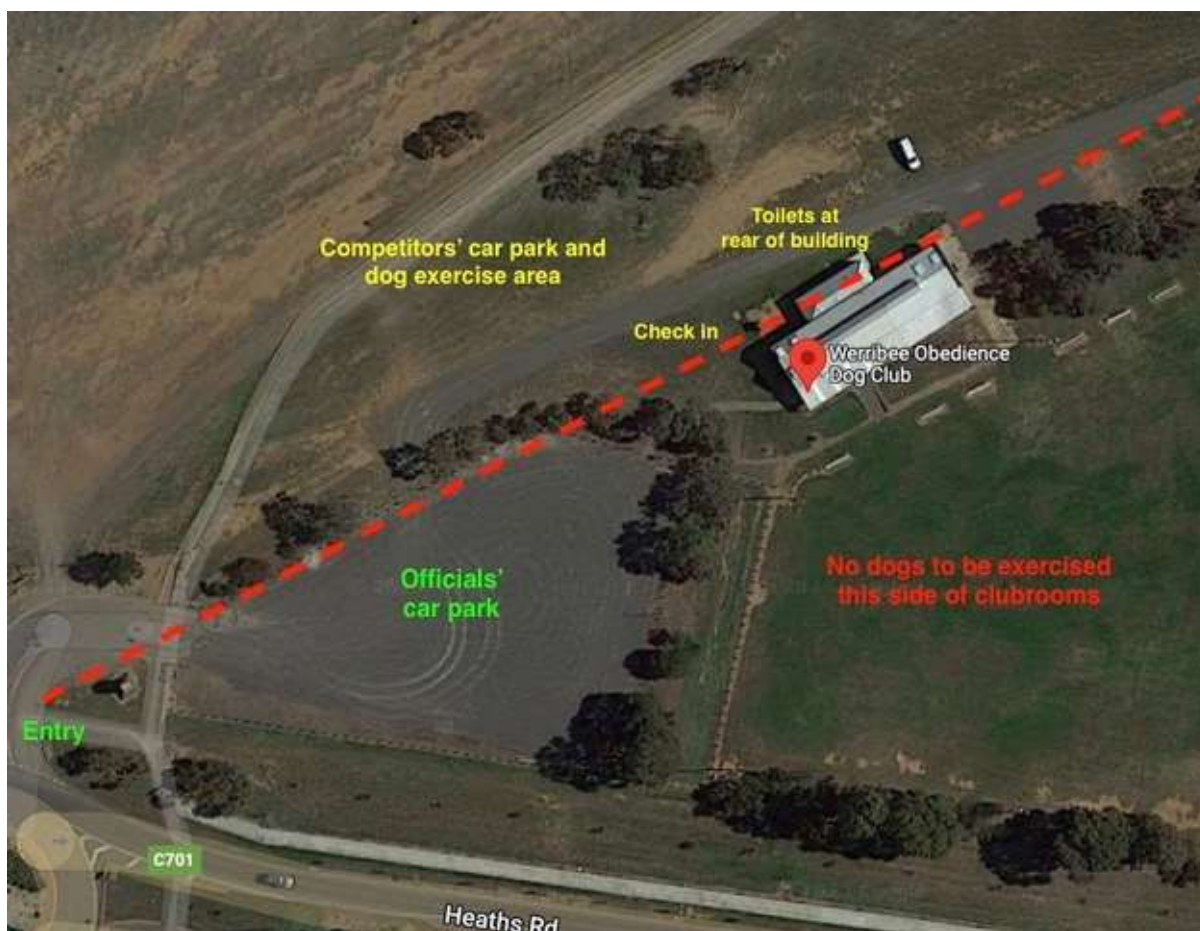
TOILET: Located in building. To access enter through door at rear of building (near competitors car park) and follow signs
