- Competitors must not bring any of the four odours (birch, anise, clove, cypress) to the venue and must not undertake any scent work training at the trial.
- Bitches in season are not permitted to enter, or be at the venue

- Qualifying Ribbons and Titles Sashes

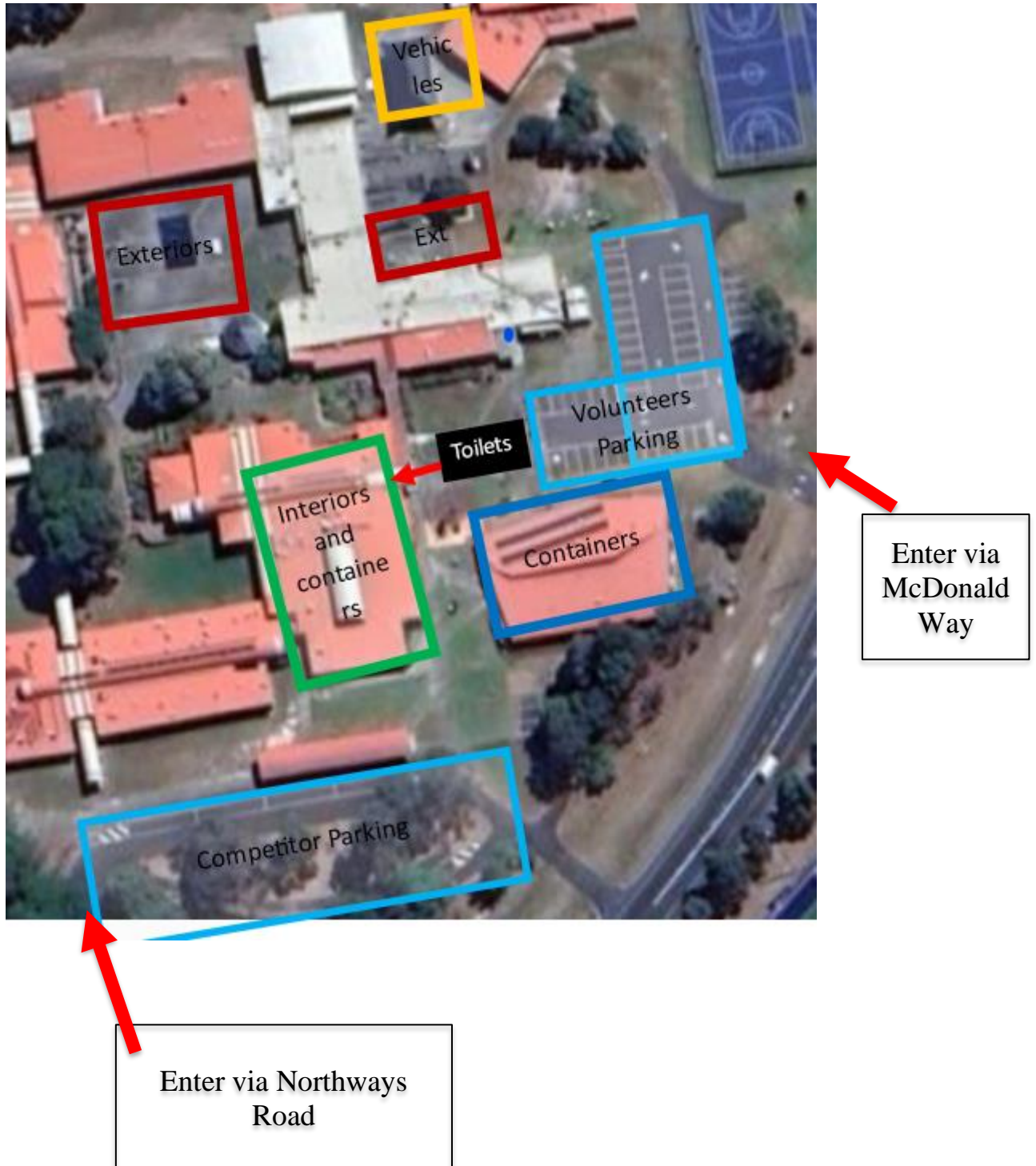
Presentations will be held at the end of Session 3. Pass cards may be available for collection at the end of Session 1.
