## TRIAL INFORMATION FOR JUDGES, STEWARDS, COMPETITORS

### **Judges/Stewards:**

- Masks are not required of any official
- There is a tub for each ring with all required sanitizer, wipes etc. These will be used as needed by all. The 1st Place prizes and all ribbons will be delivered to the rings as the Pass Cards are ready
- Judges will complete presentations at the ring at the completion of their Judging. Qualifying ribbons and title sashes will also be available for those who would like them from the Office.
- Rally score sheets will be handed to the competitor after their run. Please take these with you.
- Ring boards will be available for viewing. Please speak with the steward before touching.

### **Competitors:**

- Exhibit numbers will be provided at check on the verandah. Please only take your own numbers and be mindful of social distancing on the verandah. If there are lots of people around come back in 5 minutes we will ensure that everyone gets the opportunity to check in
- Competitors will vet their own bitches and these cards will be stamped for you
- The club has **no** requirement for additional tubs/boxes/bags etc to be provided at the ring to separate items. Judges will manage their ring in the manner they see fit and we ask you follow their direction. Stewards will have sanitized their hands throughout the day and will provide items to the handlers.
- Competitors will need to keep their own lead in the ring for rally
- Rally walk through requirements are as per the rule book. Judges will ensure everyone has their walk through opportunity.
- Ring boards will be available for viewing. Please speak with the steward before touching.

- If you deem it necessary have a mask handy and use as you require
- Catering will be available throughout the day. Please give everyone space near this area.
