Please adhere to trial officials instructions when in the trial area.

Please be mindful of responsible dog ownership, and keep your dog under control, and on lead over the weekend, please ensure you have poo bags on you and use them when necessary. When taken to your tracking area, you are reminded that competitors are asked to stay within the vicinity of the parking area until directed by the judge or steward/s.

Tracklayers: Most tracklayers will be arranged in advance by the judges but in case the unexpected occurs, please have a start article and four articles on your person as you leave home so you can lay a track if required.

Ballot: Unfortunately we had to ballot and please note that everybody entered was put into the ballot including judges and helpers. All names were put into a box and an independent person withdrew the number of entries that had to be balloted due to the land we were able to use.
