2024 STATE RALLY TRIAL CHAMPION - Judges: Mrs L Piper & Mr E. Eades

All qualifying Class Winners are invited to compete for this award. Participation is not compulsory. Entry will be restricted to one round per dog and handler team. Judging will take place over a modified Novice course. The highest qualifying score will be the Winner, should scores be level, the award will go to the fastest time, should times be equal the Winner will be determined at the discretion of the Judges

This class will be judged at completion of all classes at the Sunday Rally Trials. The winner will be awarded the title of 2024 State Rally Champion.
