- The club reserves the right to add, substitute or switch judges and alter run orders of classes.
- Contracted judges may compete at the trial in classes they are not contracted to judge
- All dogs and handlers must be registered with ANKC
- If entries are in excess of 30 for Excellent elements or 50 for Advanced elements a ballot will be held on Sunday 18th Aug 2024 at the Hastings & District Obedience Dog Club and competitors will be notified.
- Scent work training must not be carried out on the trial precinct during the trial.
- Competition odours must not be brought to the trial precinct by competitors.
- Please be familiar with the Scent Work Rules especially regarding the eligibility to enter & spectators.
- Please note that the ground at the venue can be rough in places and there are steps along pathways, into buildings & entry may be tight into some search areas. Dress appropriately for outdoor conditions.
