- The club reserves the right to add, substitute or switch judges and alter run orders of classes.
- Contracted judges may compete at the trial in classes they are not contracted to judge
- All dogs and handlers must be registered with ANKC
- If entries are in excess of 80/judge, a ballot will be held on Sat 7th Sept 2024 at the Hastings club.
- A refreshment break may be taken part way through the judging as required. Details will be provided at briefings and where possible in the catalogue.
- Scent work training must not be carried out on the trial grounds during the trial.
- Competition odours must not be brought to the trial precinct by competitors.
- Attendees are reminded not to speak about the search areas at the trial prior to completion.
- Please note: The trial grounds does have rough walking surfaces and steps into buildings in places
- Please be familiar with the Scent Work Rules especially regarding the eligibility to enter & spectators.
- This trial is be run as a single trial and if am/pm check-ins are offered this is for competitor convenience and to allow for ample car parking where possible.
