- Eligibility for the award is based on the following condition being met:
- The Class winner is a current financial member of the SSCV at the closing date of the trial as advertised in the Schedule.
- The Highest Scoring Non-titled Rally Advanced dog will be the winner of the trophy. The dog will not have achieved their Rally Advance Title prior to the trial.
- The Ruth Laughlin Memorial Trophy will not be awarded if the above criteria is not met.
