<u>Awards</u>: Rosettes for 1st, 2nd and 3rd places (qualifying scores only).

Best in Trial Trophy for Ultimate (If there aren't any Ultimate passes, non-qualifying scores may be eligible for this award).

<u>**Presentations:**</u> The presentations will be at the conclusion of the day.


<u>Catering</u>: We apologise that catering is not available, so please bring everything you need for yourself and your dog.
