Parking:

Aim to park on the gravel carpark to the R of the driveway on entering the main gates.

Catalogue:

On the next few pages you will find the catalogue details. Your catalogue order is your run order.

Please endeavor to be ready for your number to be called. There is no need to crowd the marshal areas...but if you are standing further away – please wave to your marshal and let them know where you are listening and waiting

Clashes between rings do sometimes occur and we understand if you are swapping dogs for a different class – but please let the marshal know you are on your way and be efficient with the changeover.

Notes to remember:

Be respectful to the judges, the stewards and Marshalls at all times.

Be mindful of your space to other people and dogs – even if you know them – sometimes dogs just want to work and don't want to play!

No scent work odours to be present at the venue at the trial – if you happen to have found some in your possession – bring to an official at check in and it will be placed away with the odour in the hot rooms – and can be collected at the end of the trial.
