- The club reserves the right to add, substitute or switch judges and alter run orders of classes.
- Contracted judges may compete at the trial in classes they are not contracted to judge
- All dogs and handlers must be registered with Dogs Australia
- If entries are in excess of 90/judge, a ballot will be considered and if required will be held on Sat 11th May Jan 2025 using the Top Dog automated Ballot system.
- A refreshment break may be taken part way through the judging as required. Details will be provided at briefings and where possible in the catalogue.
- Scent work training must not be carried out on the trial grounds during the trial.
- Competition odours must not be brought to the trial precinct by competitors.
- Attendees are reminded not to speak about the search areas at the trial prior to completion.
- Please note that the ground at the venue can be rough in places and there are steps along pathways, into buildings and entry may be tight into some search areas.
- Please be familiar with the Scent Work Rules especially regarding the eligibility to enter and spectating.
