It is handler responsibility to be there at briefing and ready to leave when requested by Judge.

Judging Commences

Commencing Judging at 6:30 pm for night tests,
Commencing Judging at 11am for day tests,

Note: It is handler responsibility to ensure that they have correct equipment available for their dog and themselves before starting track. Handlers are expected to wear reflective vests and have head lamps (for night tracks) as outlined in the ANKC Rules and Guidelines. As the test locations are not at KCC Park, competitors will need to be ready to follow the relevant judge/steward vehicle when requested.

Please note that for safety reasons, Judges and stewards are provided mobile phone lists for all competitors allocated to them to ensure competitors can be found when needed.

Awards Presentations are at the conclusion of all judging each session (afternoon /night).

Title Sash/qualifying ribbon & Pass Card for qualifying tests.

Special Awards: Excellent Medallions for eligible German Shepherd Dogs receiving an Excellent pass rating.
