Check-in: 7.45am to 8.15am (No Vetting). Afternoon only competitors must arrange number collection with the Trial Secretary before the trial.

Awards: Sash/Ribbons for 1st, 2nd & 3rd qualifying placings in each height in each class other than Open classes which will have one sash/ribbon for overall 1st, 2nd & 3rd qualifying placings. Qualifying and Title ribbons available. Presentation to be held at the conclusion of the trial (after equipment pack-up).
