Bitches in season are not permitted to compete in sporting events. Only in conformation and property classes. Committee may enter events including the championship show.

Dogs must be on the main register for all classes including neuter.
	Property Classes: Mrs Joy McInnes (VIC)	8:30am	22 – Best Head, 23 – Best Coat, 24 – Best Tail, 25 – Best Gaited, 27 – QC	QC: for any exhibit entered in the regular classes that has a qualifying score in another discipline such as field, obedience, retrieving, agility, etc. A copy of pass or title must be supplied with entry. Dogs must be on the main register to be eligible for entry for all property classes and must be entered in the conformation show. Property classes must be entered prior to close of entries. You may enter and compete in both the property classes and the ordinary classes.
Restricted to Breed Retrieving Ability Test for Gundogs (RATG)	Mr Colin Phipps (VIC)	30 mins after the completion of the show but not before 11:00am	Novice Retrieving Ability, Open Retrieving Ability	Novice and Open will be held on dummies. Dummies will be supplied by the Club, or exhibitors may use their own provided they are approved as compliant to the rules by the judge. Water may be used at this trial.
Restricted to Breed Obedience and Rally Trial	Obedience: Mrs Raine McKay (VIC)	30 mins after the completion of the show but not before 11:00am	UDX, Utility, Open, Novice, CCD	One entry per entry form. Open and Utility must state dog's JUMP HEIGHT and all titles. Entrants in the CCD class are not eligible for Highest Score in Trial.
	Rally: Mrs Tania Schumann (VIC)	30 mins after the completion of the show but not before 11:00am	Novice, Advanced, Excellent, Master	Rally Advanced and Excellent must state dog's JUMP HEIGHT and all titles.
Restricted to Breed Trick Trial	Mrs Janette Wilson (VIC)	30 mins after the completion of the show but not before 11:00am	Starter, Novice, Intermediate, Advanced	Ring size 12mx12m
