Welcome to the Australian Shepherd Club of Victoria's Double Open Ultimate Scent Work Trials.

Order of the day

We will be utilising self-check in. Please tick your name off the list and collect your numbers and welcome gift from the Club.

Please only check in yourself and collect your own numbers.

Check in from 9:30pm at front of Donnelly building.

Judges' briefings at 10:00am at front of Donnelly building.

Judging of both trials will commence at 10:30am, running concurrently.

There will be a lunch break at approximately 12:30pm.

Presentations will be held at the conclusion of both trials.

Vetting

There will be no vetting, however bitches in season must not be present at the trial. Any bitches found in season will be asked to be removed from the trial precinct immediately.

Placing and awards

Rosette and prize for 1st, 2nd and 3rd place in each trial.

Qualifying certificates, pass ribbons and title sashes will be presented.

Important information

Please respect the trial venue so that we have access again in the future. Do not take dogs anywhere near the Church. Please also respect the private properties around the school, do not park on nature strips, or block access to driveways or footpaths.

Please pick up after your dog at all times. There is ample grassed area to toilet your dog. Bring your own bags and take all your rubbish home with you, as it is during school holidays and bins won't be emptied prior to classes resuming. Please do not allow your dog to urinate on any building, fence or other structure at the venue.

Absolutely no smoking or vaping on the grounds under any circumstances. This includes the carpark.

Dogs must be kept on lead at all times (unless in a search area, if the judge allows) to ensure safety.

There will be 'no go' areas to restrict visibility or disturbance of search areas. Please respect these and observe any signs, cones and marshal directions. **Scott Street is a NO-GO area.**

Be reminded that you must NOT discuss your search or any aspects of the search area until the trials have been completed.

Do not bring any odour (birch, anise, clove, cypress) to the venue, and do not undertake any training during the trial. Warm up boxes will be available.

Spectators: unfortunately, limited space within the venue may not allow spectators and this will be at our judges' discretion.

School Holiday Program

Please note that part of the school is being used during the trials for school holiday programs. As such please be mindful of children and carers during pick up and drop off times, especially crowding entrances and exits so no public or dogs are upset.

Trial communications

We will be utilising Top Dog Events to update you on the run order and any other important information throughout the day. There will be no marshals so make sure to keep track of where the flow is at. If anyone needs to run out of order, we will communicate it.

There will be no catering on site for competitors.
